4. The Restricted Stock Units will vest 1/3 per year beginning the last day of February 2026.

5. The performance shares convert to common stock on a 1 to 1 basis.

The actual number of shares to be received will be determined by the Compensation and Human Capital Committee in February 2028 based on the Company's ROE performance relative to a performance peer group of companies and performance relative to a pre-determined goal for growth in adjusted book value per share for the 2025 through 2027 performance period.
