Explanation of Responses:

1. The option vests in three equal annual installments beginning on February 10, 2005.

2. The Performance Shares convert to common stock on a 1 to 1 basis.

3. Represents the target number of shares to be received upon attainment of an average Return On Equity (ROE) of 10% in 2005 and 2006 based on after-tax adjusted operating income for the financial services businesses. Attainment of 12% average ROE would result in an award of 150% of target and 8% or less would result in an award of 50% of target. The actual number of shares to be received will be determined by the Compensation Committee in February 2007.
