Explanation of Responses:

2. The option vests in three equal annual installments beginning on June 19, 2003.
3. The option vests in three equal annual installments beginning on February 11, 2004.
4. The option vests in three equal annual installments beginning on February 10, 2005.
5. Represents the target number of shares to be received upon attainment of an average Return On Equity (ROE) of 10% in 2005 and 2006 based on after-tax adjusted operating income for the financial services businesses. Attainment of 12% average ROE would result in an award of 150% of target and 8% or less would result in an award of 50% of target. The actual number of shares to be received will be determined by the Compensation Committee in February 2007.
6. The Performance Shares convert to common stock on a 1 to 1 basis.
