Involuntary sales, without any action by Mr. Grier and without his knowledge, as a result of margin loan calls related to a substantial decline in the market price of the Issuer's stock held in a margin account. After the transactions reported on this Form 4, Mr. Grier continues to hold 33,907 shares directly and 17,456 shares indirectly in a 401(k) account. Mr. Grier also holds an additional 148,395 vested stock options, 182,482 unvested stock options and 79,124 target performance shares (the exact number awarded being dependent on achievement of performance goals).
