- The option vested in three equal annual installments beginning on February 14, 2007.
- The option vested in three equal annual installments beginning on February 8, 2006.
- The options vest in three equal annual installments beginning on February 9, 2011.
- Represents the target number of shares to be received upon attainment of the Company's annual EPS and ROE goals over the 2010 through 2012 performance period. The actual number of shares to be received will be determined by the Compensation Committee in February 2013.
- The options vest in three equal annual installments beginning on February 8, 2012.
- Represents the target number of shares to be received upon attainment of the Company's annual EPS and ROE goals over the 2011 through 2013 performance period. The actual number of shares to be received will be determined by the Compensation Committee in February 2014.
- The option vested in three equal annual installments on June 19, 2003, 2004 and 2005.
