Explanation of Responses:

1. Following the transactions reported on this Form 4, Mr. Lambert continues to hold 5,970 shares directly and 4,800 shares indirectly in a 401(k) account. Mr. Lambert also holds an additional 18,916 vested stock options, 14,301 unvested stock options, 2,948 restricted stock units and 1,312 target performance shares (the exact number awarded being dependent on achievement of performance goals).
2. Amount reported has been adjusted to include 51 shares of Issuer common stock acquired by the reporting person under The Prudential Employee Savings Plan between December 31, 2012 and March 31, 2013 based on a plan statement dated March 31, 2013. The acquisition of such shares was exempt from Section 16 pursuant to Rules 16b-3(c) and 16a-3(f)(1)(i)(B).
3. The reporting person disclaims beneficial ownership of these securities except to the extent of his pecuniary interest therein, and this report shall not be deemed an admission the reporting person is the beneficial owner of such securities for the purposes of Section 16 or for any other purpose.
4. The option vested in three equal annual installments beginning on February 10, 2005.
