Explanation of Responses:

1. The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$67.66 to \$67.67, inclusive. 2. Following the transactions reported on this Form 4, Mr. Sayre continues to hold 13,037 shares directly and 312 shares indirectly in a 401(k) account. Mr. Sayre also holds an additional 48,992 vested stock options, 22,330 unvested stock options, and 4,309 target performance shares (the exact number awarded being dependent on achievement of performance goals).
3. The reporting person disclaims beneficial ownership of these securities except to the extent of his pecuniary interest therein, and this report shall not be deemed an admission the reporting person is the beneficial owner of such securities for the purposes of Section 16 or for any other purpose.
4. The options vest in three equal annual installments beginning on February 9, 2011.
